sites from signage budget.

3.1.4 Signage for Blue Gum Creek bushcare site

W Goonan reported the brief for this project is in progress. Discussion confirmed that crossings should be traversable 1 day after a one in 5 year rain event. S Rees recommended that Soil conservation Services be consulted for advice on the brief.

W Goonan tabled her discussion paper showing options for obtaining the services of a ranger for inspection, supervision, maintenance and remediation works in the reserve. The subcommittee will processd to developing a specific proposal for the contractor model and submit an application to the PRMFP for funding up to \$30000.
